Executive summary

- The annual review and rebalancing for STOXX Global Thematic indices was conducted June 20, 2022
- As part of the process, the entire RBICs classification was evaluated for each index, ensuring that the targeted themes continue to be accurately reflected
- The ESG methodological criteria was also revised to take into consideration aggregated revenues from military contracting related activities
- ESG exclusions impacted from as low as 4 companies (Breakthrough Healthcare) to as high as 36 companies (Smart City Infrastructure), with Product Involvement being the largest contributor
- Average turnover was 27%, up slightly from 23% last year. This coincided with a general rise in the number of securities per index, which could be attributed to an overall net increase in the number of RBICs sectors
- All indices maintained a purity of >80% to their targeted theme, as measured by revenue






